Safe Ports Regional Gateway benefits from extensive modern infrastructure developed for road networks, electricity, water supply and wastewater, as well as fiber-optic connectivity.

Given its potential to connect overland routes with access to major regional ports and airports, Safe Ports

Regional Gateway can become a leading location for industrial production and a transportation hub for movement of goods throughout the region.



AmCham Signs Partnership Agreement w/ G4 Solutions & Resources @ The 2018 AmCham MENA Council Annual Conference & Exhibition

A one-year partnership agreement was signed between the AmCham-JO and G4 Solutions & Resources. The signing took place during the events of the 2018 AmCham MENA Council Annual Conference & Exhibition on Saturday October 27th, 2018, the agreement, which outlines areas of cooperation was signed by the CEO of G4 Solutions & Resources Mr. Raed Haddadin and AmCham-Jordan Chairman Eng. Workshop on Energy Efficiency Standards & Labeling @AmCham

The American Chamber of Commerce in Jordan, jointly with the International Finance Corporation (the World Bank Group) hosted a workshop with private sector representatives on Energy Efficiency (EE) standards and labeling on October 31st, 2018.

This workshop is implemented under the Policy Pillar of the National Tijara Coalition in support of the International Finance Corporation (IFC, a part of the World Bank Group) efforts to improve competitiveness of Jordanian producers at international markets and thus increase Jordanian export.

IFC met with private sector representatives, manufactures and traders of electric appliances and discussed with Jordanian producers' their experience in working with the energy efficiency standards and labeling, as well as their broader experiences with all parts of the National Quality Infrastructure – metrology, standardization, conformity assessment. As well as the situation with compliance of Jordanian products with standards / requirements of other markets.
