




### "Doing Business with the U.S." Workshop in collaboration with AmidEast Jordan.

February 2<sup>nd</sup>, 2022.

The workshop at the Sheraton Amman Hotel in collaboration with Amideast-Jordan, in honor of the World Industry Day 2022, and as a follow up on the workshop held back in December 6th, 2021 in partnership the U.S. Department of Commerce, International Trade Administration, U.S. Commercial Service, and U.S. Armed Forces.

The workshop aimed at helping businesses obtain the necessary registrations for U.S. government business to successfully be able to bid for tenders with the Department of Defense or other U.S. government agencies.

A detailed presentation was shared by Amideast on how to create an account and register on SAM.gov, how to obtain a DUN'S number and CAGE/NCAGE IDs. Followed by a discussion on the processes of acquisitions for supplies and services, acquisitions construction, and government purchase.





# An 'Experience- Sharing" visit to AmCham- Egypt

February 8th, 2022

The visit was very beneficial and provided an opportunity for the AmCham-Jordan team to visit AmCham-Egypt, the region's oldest AmCham and the current President of the AmCham MENA Regional Council.

Ms. Raghad Alkhojah CEO, AmCham-Jordan Both AmChams had the opportunity to share knowledge and learn from one another's experiences, particularly in primary key areas of work such as trade and investment; research and publication; policy and advocacy; training and capacity building; and fundraising.

During the three working days, the team attended extensive sessions and held back-to-back meetings with directors of the various components at AmCham-Egypt. On Day I, the sessions covered the following topics: Publications and Research; Business Development; Trade and Investment Promotion Activities; and the AmCham MENA Regional Conference.

On Days 2 and 3, the following topics were covered: Career Development Centre (CDC), Membership Services, Finance, and Programs and Operations.

The team benefited from all of the information and samples provided by AmCham-Egypt, and they will assess what working processes, marketing and sales techniques, and/or products can be replicated in AmCham-Jordan based on what is applicable.

#### March 7th, 2022

AmCham-Jordan and EEConsult signed a Memorandum of Understanding on March 7, 2022. EEConsult is the exclusive representer and partner of NABCEP in the MENA region as NABCEP MENA, and it is the only authorized party to offer, provide, develop training programs and courses accredited by NABCEP in the MENA region.

EEConsult has developed a new training program in the field of renewable energy, precisely in the topic of Electrical Vehicles (EV) and Battery Storage (BS) that applies and covers the segments of EV and BS business, EV and BS policies, and EV and BS technology as each segment constitutes one training course.

The main objective of the MoU is to collaborate on providing and promoting this training program in Jordan and the MENA region, which will be the first accredited training program of its kind in EV and BS to be offered by EEConsult as NABCEP MENA.

AmCham-Jordan and EE Consult will also host networking events to facilitate information, knowledge, and technical advice exchange between Jordanian and US businesses, as well as between Jordan and the US.

#### Workshop on Subsidies for the **Manufacturing Sector** March 7th, 2022

The workshop comes after the Government of Jordan's cancellation (end of 2021) of the Regulation to Support the Manufacturing Activities No. 13 for 2020, and the announcement in December 2021 of its intention to set up a Manufacturing Support Fund.

The proposed Fund falls under the third pillar of the Government's Economic Work Priorities 2021-2023: "Supporting Priority Economic Sectors/ Industries," to provide companies with access to financial support and enhance their export readiness to competitiveness as well as to grow their export promotion activities.

Dealing with subsidies for the manufacturing sector is central to support companies overcome some of the negative economic implications of the COVID-19 pandemic and continue to be competitive on the regional and global levels.

In the design and implementation of national subsidies schemes, Jordan should conform to the Agreement on Countervailing Measures (Subsidies Agreement) of the World Trade Organization (WTO).

The workshop was offered by Marius Bordalba Layo, an International Trade Policy Expert and Senior Consultant, and Lana Nimri, AmCham- Jordan's Legal Advisor, Head of the JUSFTA Unit - who provided an overview of the rules of WTO Subsidies Agreement, experiences of like developing country economies in offering subsidies, and possible options available for Jordan.

CIPE is the world's only institution dedicated to promoting democracy and strengthening the private sector. CIPE was founded on the principle that economic and political freedom are linked.

During her visit, Ms. Alkhojah emphasized the importance of establishing strong democratic institutions in order to foster a conducive environment for business and entrepreneurship.
