A free trade agreement (FTA) is an international treaty between two or more economies that reduces or eliminates certain barriers to trade in goods and services, as well as investment.

Jordan has been a member of the World Tarde Organizations since 2000, joining the multilateral training system ensures that Jordanian traders are able to access over 160 economies based on predictable and transparent rules.

Jordan has negotiated several FTAs to benefit Jordanian exporters, importers, producers and investors by reducing and eliminating certain barriers to international trade and helps attract investments.

This coupled with Jordan's strategic location, friendly business environment, modern transportation system and a strong communication network makes Jordan an ideal location for enhancing products international competitiveness and expansion into attractive markets.

Jordan's FTAs gives exports preferential access to over **1 billion consumers** worldwide, and helps reduce import costs for Jordanian businesses and consumers.








GSP & Other Trade Arrangements

Jordanian goods also benefit from tariff reduction on various products exported to certain developed country donors.

The Generalized System of Preferences (GSP) is a framework under which developed countries give preferential tariff treatment to goods imported from certain developing countries.

Countries that offer Jordanian goods certain **tariff reductions or benefits** from other preferential arrangements



Jordan-U.S. Qualifying Industrial Zones Arrangement

The U.S. Congress enabled the establishment of Qualifying Industrial Zones (QIZs) in Jordan in 1996 with the objective to further increase market access of Jordanian companies to the U.S. market.

Products manufactured within the identified and agreed zones qualify for duty-free and quota-free access to the U.S. provided certain conditions are met, of at least 35% Jordanian content, of which 11.7% must come from a Jordanian QIZ; 8% from Israel (7% for high-tech goods), with the remainder of the minimum may be fulfilled by content from a Jordan QIZ, Israel, U.S., or West Bank/Gaza. And 20% Jordanian content complemented by 15% U.S. content.

Since the entry into force of the JUSFTA Jordanian exports to the U.S. through the QIZ share has significantly declined. Noting that Egypt also benefits from the QIZ arrangement.

Jordan - EU Simplified Rules of Origin Scheme

In July 2016, the EU and Jordan agreed to simplify the rules of origin that Jordanian exporters use in their trade with the EU until 21 December 2030.

The scheme allows producers in Jordan to use an alternative more flexible set of rules of origin for exports to the EU other than the pan-Euro-Mediterranean protocol on rules of origin, whereby up to 70% of material used in the manufacturing process can be non-Jordanian, and provided that up to 15% of the manufacturer's employees are Syrian refugees, until the overall target of Syrian employment is reached, which is least 60,000 legal and active job opportunities for Syrian refugees.

Manufacturers in the whole of Jordan can benefit from this scheme within 52 different product categories including textiles and garments, engineering and electrical products, chemical products, plastic products, and furniture and wood products.

Jordan-U.S. Free Trade Agreement Unit was established in 2017 with support from the United States Agency for International Development's (USAID), to provide specialized technical advisory services to Jordanian and American businesses to better understand and utilize the trade and investment opportunities made available under the JUSFTA and the BIT. The JUSFTA Unit also serves as Secretariat to the National Tijara Coalition, Jordan's oldest public private dialogue platform.
